



## Angelo Anthony SanGiovanni

Williamsburg - Angelo Anthony SanGiovanni, 72, of West Warwick, RI passed away August 5, 2012 at his new home in Virginia. Angelo was born on May 19, 1941, in Providence, RI. He received his B.A. in Psychology and a Post-Graduate Studies Certificate in Behavioral Psychology, Clinical Hypnosis and Sexual Disorders from Rhode Island College. He worked as a counselor and curriculum advisor for autistic children and adults at Behavior Research Institute in Massachusetts before his early retirement due to complications from Multiple Sclerosis.

Angelo was a talented musician and played keyboards and other instruments as a member of a rock and roll band called Contingent in the 1960's and early 70's. He performed with bands Chicago, Three Dog Night and the Righteous Brothers. Angelo was also a certified Emergency Medical Technician EMT with the North Providence Fire Department in 1980's. He was a professional photographer and an avid fan of amateur radio. Angelo is best known by all for his serious addiction to baseball and his beloved Boston Red Sox.

Angelo was predeceased by his wife, Elena Viola SanGiovanni and his parents Anthony SanGiovanni Sr. and Antonetta Gugliomotti SanGiovanni of North Providence, R.I.

He is survived by his son, John A. SanGiovanni and wife Paulette of Suffolk,

Virginia; daughter, Lee Ann Mann and husband Robert L. Hildreth of Rockingham, North Carolina; grandchildren, Shaye Lapierre, Michael SanGiovanni, and Jay SanGiovanni; brother, Anthony SanGiovanni Jr. and wife Ann of Warwick, Rhode Island.

The family will receive friends at Loving Funeral Home, Churchland Chapel, on Friday, August 31 at 3 pm. A reception will follow at the home of John and Paulette SanGiovanni.
