David C. Breslauer passed away surrounded by his family on Sept. 26, 2010 at home in Suffolk after a battle with cancer. He was 76.

Dave was born in Orange, NJ in 1934 to the late Edward J. and Frances C. Breslauer.

He lived in Portsmouth VA for 22 years before moving to Suffolk in 1982.

Mr. Breslauer served in the Navy during the Korean War from 1952-1956 on the USS Ticonderoga Aircraft Carrier.
