David Wayne Fries passed away on July 19, 2008, at the age of 48. David graduated from Kennesaw College in 1981 and received an MBA from Radford University in 1993. He was Director of Risk Management for Norfolk Southern Corporation, where he was employed for 24 years. He was an avid runner and a member of Tidewater Striders. He was a dedicated father, who spent many years coaching all of his children's sports and was actively involved as a volunteer in the choral and orchestral programs at Western Branch High School.

David is survived by his wife, Beni; a daughter Kristen; 2 sons Scott and Austin; his father and mother; Don and Bev; a brother Dan, and a sister, Karen.

Funeral services will be held Wednesday, July 23, at 2:00pm at Saint John's Episcopal Church in Portsmouth, VA. The family will receive friends in Loving Funeral Home, Churchland Chapel Tuesday, July 22, from 7-8p.m. In lieu of flowers, the family asks that memorial contributions be made in David's memory to The Preston Robert Tisch Brain Tumor Center at Duke, DUMC Box 3624, Durham , NC 27710.

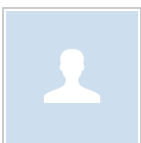
