



Raymond Holmes Strople

October 14, 1940 - August 25, 2006

Raymond Holmes Strople of Suffolk passed away in the late evening of August 25, 2006. Born in Longmeadow, Massachusetts to the late Raymond and Julia Hammatt Strople, Ray was a graduate of Norwich University in Vermont and the Marshall Wythe School of Law at the College of William and Mary in Williamsburg, VA.. After clerking for Virginia Supreme Court Justice Lawrence W. I?Anson, Ray went on to a distinguished career in Law and worked for over 35 years at the Moody law firm in Portsmouth, VA.

He treasured his time with his family and friends, as well as time spent on volunteer and charity work, including his passion for youth sports, Hospice, and his church, Green Acres Presbyterian of Portsmouth, VA. He enjoyed playing golf and watching his cherished Yankees, Redskins, and William and Mary Tribe.

Ray is survived by his wife, Elaine; his four children, Meg Tollison and husband David of Dallas, TX, Dr. Jennifer Strople of Chicago, IL, Michael Strople and wife Monica, of Chicago, IL, Chad Harris and wife Dr. Ami Claxton-Harris of Cary, NC; three grandchildren, Lauren, Lily and Julian; a special niece, Alayna, who all adored their "Papa"; his two siblings Angie McGinnis of Portland, OR and Peter Strople & wife Judy of Florence, Ky; and a host of nieces and nephews who doted on "Uncle Ray."

A memorial service will be held on Monday, August 28, 2006 at 11:00 am at Green Acres Presbyterian Church in Portsmouth VA.
